## New Eagle Palm Requirements—How To



Recent changes to way Eagle Palms are awarded has prompted new guidelines and paperwork from our Council. At the time of the Eagle Board of Review, the District Representative will provide the Scoutmaster or designee with a form for recording merit badges used to earn the Eagle Palm(s), a council advancement report for the scout listing all merit badges the scout has earned, and instructions for using the new form. Simply complete the form and return to the District Representative after the board of review. The District Repwill submit the form along with the Eagle packet. The earned Eagle Palms will be included with the Eagle Rank insignia at the time of pick up at the Scout Office.

# **Revised Campout Requirement for Second Class, First Class**



The number of overnight campouts required for a young man to earn the Second Class and First Class ranks has been reduced under new requirements that too effect Aug. 1, 2017

The revision return the number of overnight campouts to pre-2016 levels but preserve the amount of time spend outdoors. The change, the BSA says, maintains the focus on life changing outdoor experiences while recognizing that not all outdoor activities need to include overnight camping.

These changes do not affect the requirements for the Eagle-required Camping merit badge.

Per section 4.0.0.1 of the BSA Guide to Advancement, scouts can choose to follow to newly established reduced campout requirement or he can choose to follow the requirement as written in the current edition of the Boy Scout Handbook. On January 1st, 2018, all scouts will need to comply with the reduced campout requirement that went into effect on Aug 1st, 2017

Learn the "nuts and bolts" regarding the steps that occur after a Scout thinks he has completed all requirements for Scout to Eagle Scout ranks. Topics will include Scoutmaster Review, Eagle Rank Application, Letters of Reference, differences in the Eagle Board of Review and other rank reviews, final evaluation of the Eagle Service Project and the appeals process.

Learn about the Eagle Scout Service Project Workbook and the process relating to it. The responsibility of the Scout and the role of supporting adults will be explained. The aim of this part of the course is to provide all the necessary information required so that the Eagle Scout candidate may successfully complete his project. The Eagle Scout Project Workbook will be fully explained. Life Scouts are eligible to attend this session for personal information and understanding in preparing, planning and executing their Eagle Scout project.

Life Rank Scouts are welcome and encouraged to attend this course, especially from the 10:00 am until noon session.

### Eagle Palm Requirements Changing (article taken from Bryan on Scouting)



Eagle Palms are bronze, gold and silver awards presented to young men who earn five, 10, 15 or more merit badges beyond the 21 required to become an Eagle Scout.

Last week, the BSA has announced significant changes to the way Scouts earn Eagle Palms. The modifications take effect Aug. 1, 2017.

The changes bring Eagle Palm requirements in line with the needs of older Scouts. The National Boy Scouting Subcommittee has eliminated unnecessary obstacles, such as the Eagle Palm board of review, and expanded the definition of active participation.

But the biggest change affects young men who haven't yet earned Eagle. Beginning Aug. 1, all earned Palms may be awarded instantly to new Eagle Scouts at their Eagle court of honor. This abolishes the wait of months or years for these young men to receive all Palms available to them.
